**Sub: Provisional registration and course work schedule for admission to Ph. D Program
2021-22 winter and ADF.**

The candidates selected for PhD admission winter 2021-22 (and previously admitted candidates who have not yet attended course work but are eligible for the same) as well as candidates admitted for admission to autonomous colleges are required to get themselves registered provisionally by following the online process <https://phd.ptu.ac.in/Default.aspx>. The following is the schedule:

- Activation of Online Provisional Registration Form (In the login id of selected candidates): **19-05-2022**
- Last Date to fill the online provisional registration form: **26-05-2022**
- Last Date to deposit the fee: **26-05-2022** (Provisional Registration Fee = Rs. 25000/- + course work fee = Rs. 30,000/- Total Fee = Rs. 55,000/-). The fee will be deposited through online mode only (Credit Card/debit Card/Net banking etc.), after the student has submitted the online provisional registration form.
- The student selected under JRF has to attend course work at IKGPTU Main Campus, Kapurthala.
- Please note that course work is being held at IKGPTU Main Campus Kapurthala and some other research centres at different locations. Each centre will be offering some selected core/elective subjects in concerned branches. It is advisable that student opts for attending course work at any location as per availability of desired subjects at that location. If possible, student can seek guidance/advice of their supervisors before opting for the subjects/location depending upon their tentative research area. Student has to give three choices of research centres in order of preference in his/her provisional registration form. The University will allot the centre as per choice of student but subject to administrative feasibility.
- After successful submission of the provisional registration form, student can download and print the submitted form. The students, who are employed, are required to get the form forwarded from their current employer only. For citing the concerned faculty as supervisor in an application

form filled by the candidate, the candidate are required to get prior consent via signature of proposed supervisor over the printout of provisional registration form.

The students, who have not opted for a supervisor, they must finalize the supervisor after start of course work and would submit the **written consent of supervisor to the university latest by 08-06-2022.**

- **The University will allot research centre to all students latest by 30-05-2022.**
- **The Students will report at allotted research centres at 10:00 am on 31-05-2022** for subject allotment to be done by the respective research centres. The documents required to be produced at research centre are as under:
 - Print out of provisional registration form.
 - Any one photo-ID proof in original (e.g. Aadhar card, driving license, voter-ID, passport etc.)
 - Relieving certificate from current employer (for in service students, as per performa attached in login id) as the student is going to attend course work classes in regular mode only.
- **The course work classes will be started in the upcoming semester.**
- **Submission of migration certificate by the student in the university latest by: 08-06-2022**
- If the candidate fails to deposit fee by the last date i.e. 26-05-2022, his provisional registration process shall be automatically cancelled for the session 2021-22 winter and ADF. Such candidates will be considered for provisional registration in next sessions only as per their validity of admission. Please note that a student once admitted to PhD program can attend course work in current session or next consecutive session and not beyond that.
